The lot is located on the corner of Ridgeley and Burkhart. The proponents believe that the proposed fence does not affect the City's Right-of-Way or adds no obstruction to the line of site for either the intersection of Ridgeley or Burkhart Drive. The proponent seeks relief in the form of a variance, or a special exemption due to the fact that his pie shape irregular lot creates a hardship and the change doesn't have any effect what so ever on the neighbors.
